Description of Requirements:

The Tobago Regional Health Authority invites eligible registered and certified Medical Consultants (Cardiologist) to provide Clinical Cardiology Services at the Tobago Regional Health Authority. All services and certifications MUST follow guidelines of the Medical Board of Trinidad & Tobago.

Terms of Reference:

Clinical Cardiology Services

- 1. The Cardiologist must provide outpatient clinical services in all areas of cardiology weekly with a session defined as 8hrs.
- 2. The Cardiologist must read all cardiac ECHOs and provide reports in a timely manner.
- 3. The Cardiologist must evaluate and interpret Cardiac Holter monitors and cardiac stress testing with reports to referring team.
- 4. The Cardiologist must provide inpatient consultation services weekly and provide feedback to the referring team.
- 5. The Cardiologist must provide expert evaluation and assessment of patients who would qualify for cardiac care and peacemaker implants.
- 6. The Cardiologist must report to the Head of Department of medicine and the Medical Chief of Staff.
- 7. The Cardiologist must provide supervision to Registrars and House Officers assigned to the service for continuity of care.
- 8. The Cardiologist must advise the Medical Chief of Staff and Head of Department on service delivery and equipment purchase or process improvement.
- 9. The Cardiologist must provide clinical oversight to the Echo cardiographer as needed.
- 10. Document and maintain up-to-date case records.

Eligibility Criteria:

- Interested Medical Consultants (Cardiologist) must provide information indicating that they are qualified to perform the services (brochure, description of similar assignments, experience in similar conditions, availability of appropriate skills, etc.
- Registration Certificate from the Medical Board of Trinidad and Tobago

Submission of EOI:
