Description of Requirements:

The Tobago Regional Health Authority invites eligible registered and certified Medical Consultants to provide Gastroenterology Services at the Scarborough General Hospital. All services and certifications MUST follow guidelines of the Medical Board of Trinidad & Tobago.

Terms of Reference:

The Medical Consultant will be required to provide Gastroenterology Services, as follows:

- 1. The Gastroenterologist will report to the Head of Department of medicine or the Medical Chief of Staff as indicated.
- 2. The Gastroenterologist will provide clinical care to patients with gastrointestinal illnesses at the Tobago Regional Health Authority.
- 3. The Gastroenterologist will review patients in collaboration with the department of medicine and the department of surgery at the Tobago Regional Health Authority.
- 4. The Gastroenterologist will review patients who are identified for endoscopy and provide such.
- 5. The Gastroenterologist will provide clinical services on a sessional basis weekly. Each session defined as 8hrs of clinical service for endoscopy and colonoscopy. Total ten (10) procedures weekly.
- 6. The Gastroenterologist will do one outpatient clinic weekly on a sessional basis

Eligibility Criteria:

- Interested Contractors/Service Providers must provide information indicating that they are qualified to perform the services (brochure, description of similar assignments, experience in similar conditions, availability of appropriate skills, etc.
- Registration Certificate from the Medical Board of Trinidad and Tobago
