Instructions to Bidders

- Contractors must be registered and pre-qualified on the Office of Procurement Regulation (OPR) Procurement Depository under the applicable Line of Business by the tender submission deadline. Failure to be pre-qualified by the submission deadline shall result in the bid being deemed non-responsive and will not be considered further. Confirmation of pre-qualification does not preclude the TRHA from conducting further due diligence, verification or eligibility assessments at any stage of the procurement proceedings.
- Interested Bidders are required to register via the e-Tender application website at <https://tha.etenderworld.tt/> to access the Invitation to Bid (ITB) Document. Should a Bidder require assistance with accessing or using the e-Tender application, an email enquiry may be submitted to tenders@trha.co.tt. To facilitate a response, the enquiry should include the following information:
 - The Supplier's business name, address, telephone number.
 - The name, designation, email address and direct contact number of the Bidder's designated representative for the purpose of the ITB.
- A pre-tender site visit is scheduled for **10:00 am on Thursday 3rd September, 2026 at Scarborough General Hospital Food Court**. Interested Bidders or their representatives are required to attend the **mandatory site visit**. Any further information/ clarification you require can be obtained via the Procurement Unit at tenders@trha.co.tt.
- The ITB Document will be issued via the e-tender platform at no cost.
- Tenders (Bids) must be accompanied by the following:
 - Valid Income Tax and Value Added Tax Clearance Certificates or Letter of Exemption issued by the Board of Inland Revenue and dated not more than six (6) months prior to the closing date of the tender.
 - Valid NIS Certificate of Compliance or Letter of Exemption in accordance with the National Insurance Act.
 - Evidence of current registration and pre-qualification status in the Office of Procurement Regulation (OPR) Procurement Depository.
 - A list of owners of the organization, a copy of the company's Certificate of Incorporation/Business Registration and a Notice of Directors must be submitted with the tender.
 - Companies or Entities sharing Directors, Shareholders, or Ownership structures will not be treated as separate and may be disqualified to prevent potential conflict of interest or collusive bidding. Each submission must represent an independent and bona fide offer. Any evidence of collusion, coordinated pricing, or shared control among bidders will result in immediate disqualification and will be reported to the Office of Procurement Regulation.

Failure to comply with the above will result in tenders being disqualified.
- The contract will be awarded in accordance with the pre-defined evaluation and qualification criteria outlined in the bidding document.

- All bids and supporting documentation shall be submitted in the English Language. Bidders will be evaluated in accordance with the eligibility, qualification and evaluation criteria contained in the Invitation to Bid.
- LATE bids will NOT be accepted or considered under any circumstances. The e-Tender portal will automatically close at the specified submission deadline.**
- The TRHA reserves the right to cancel the present notice in whole or in part, without reimbursing any cost incurred by any Bidder in submitting their Bids.
